Releasor hereby assumes full responsibility for the risk of bodily injury, death or property damage due to the negligence of Releasees or Owner or otherwise while in or upon the premises described above while competing, officiating, working or for any purpose while participating in basketball or other sport activities at said location. Releasor hereby expressly agrees that this release, waiver, hold harmless and indemnity agreement is intended to be as broad and inclusive as permitted by the laws in the State of Michigan and that if any portion is held invalid it is agreed that the balance shall, not withstanding, continue in full legal force and effect. In the event of any injury to any Releasor, permission is hereby given to the Releasee to authorize that first aid and medical attention is given to the Releasor who is injured. The Releasor represent(s) and warrant(s) that the individual on whose behalf this document has been signed is in good physical condition and health and able to participate in the activity which may be the subject hereof and the Releasor acknowledge(s) and agree(s) that said activity may be injurious and will likely require the assistance of unscreened and/or untrained volunteer coaches and other such volunteers and individuals. The Releasor hereby knowingly and voluntarily waive any notice of any liability for which indemnity may be sought by the Releasee and Owner and the Releasor agree(s) that the obligation to indemnify shall survive the end of any participation which gave rise thereto.
